SUBJECT: 2nd Call for Nominations for the 2025-26 MUNFA Executive Committee and Nominating & Balloting Committee

The MUNFA Nominating & Balloting Committee is soliciting nominations for 2025-26 Executive Committee and Nominating & Balloting Committee.

Academic Staff Members (ASMs) from equity-seeking groups are encouraged to put their names forward. The Nominating & Balloting Committee also are looking for nominations from all campuses, representing a range of Faculties and Schools, including both tenure-stream and contractual Academic Staff Members (ASMs). As per the MUNFA Constitution, any Bargaining Unit member is eligible to hold office with MUNFA.

Please note that as per [Clause 1.20](#) of the MUN/MUNFA Collective Agreement, “*An ASM’s service to the Association shall be deemed academic service as set out in the appropriate articles in this Collective Agreement.*”

Official nominating forms for the Executive Committee and Nominating & Balloting Committee (linked below) must be accompanied by the signature of the nominee indicating their willingness to serve, and the signatures of a proposer and seconder. All three must be members of MUNFA.

The nomination period ends at noon on March 4, 2025 Each candidate has the option of submitting a statement of *not more than* 150 words which shall be circulated in the case of a contested election. Such statements must be received by the MUNFA office by noon on March 5, 2025. For the 2025-26 Executive Committee, the following nominations have been received to date; **should there be more than one nomination for a position, an election will follow.** ([Nomination Form](#))

- *Vice-President External/President Elect (1-year term)*
- Secretary (2-year term)
- One (1) Member-at-Large - **Grenfell Campus** (one 2-year term)
- Four (4) Members-at-Large (three 1-year terms and one 2-year term)

**Following their 1-year term as Vice-President External, the person will then move into the position of President and in the subsequent year, move to the role of Past President.*
