SUBJECT: Second Call for Nominations for the 2026-27 MUNFA Executive Committee and MUNFA Nominating & Balloting Committee

The MUNFA Nominating & Balloting Committee is soliciting nominations for the 2026-27 Executive Committee and Nominating & Balloting Committee.

Academic Staff Members (ASMs) from equity-seeking groups are encouraged to put their names forward. The Nominating & Balloting Committee also are looking for nominations from all campuses, representing a range of Faculties and Schools, including both tenure-stream and contractual Academic Staff Members (ASMs). As per the MUNFA Constitution, any Bargaining Unit member is eligible to hold office with MUNFA.

Please note that as per [Clause 1.20](#) of the MUN/MUNFA Collective Agreement, “*An ASM’s service to the Association shall be deemed academic service as set out in the appropriate articles in this Collective Agreement.*”

Official nominating forms for the Executive Committee and Nominating & Balloting Committee (linked below) must be accompanied by the signature of the nominee indicating their willingness to serve, and the signatures of a proposer and seconder. All three must be members of MUNFA.

The nomination period ends at noon on February 18, 2026. Each candidate has the option of submitting a statement of *not more than* 150 words which shall be circulated in the case of a contested election. Such statements must be received by the MUNFA office by noon on February 19, 2026.
